Personal Data Processing Agreement

By filling in and sending this registration form I grant to the company Sacred Dance s.r.o., with the registered office at Jana Morávka 504, 254 01 Jílové u Prahy, which is registered at the Municipal Court in Prague, file no. C 304574, Company ID: 07650558, and to all partners of the events, as stated at the event website (hereinafter referred to as “administrators”), in accordance with the appropriate provisions of the Act No. 101/2000 Coll. and the Act No. 480/2004 Coll., the consent with the processing of their personal data stated in this form, for the purpose of verification of the valid participation in the appropriate event, for which I have registered or will register in future at www.sacreddance.cz, for other business and marketing purposes of administrators as well as for the purpose of sending information on events, all of which for the period of 10 years. The provision of personal data is key for the conclusion of the agreement with the administrator and for its subsequent fulfilment.

I also agree with the publication in the extent of name, surname in the media and at the website of the particular Event. I also express my consent with the fact that these personal data are fully processed for the above-stated purposes also via third persons authorized by any of the administrators, particularly for the purpose of receiving payments and verifying payments for the participation at the event. The administrators are authorized to allocate to these personal data also other personal data related to my person (e-mail, webpages, telephone). The provision of personal data is voluntary.

I provide a consent for the administrator to use my portrait, my writing, pictures or images, video and audio records related to my person or my personal manifestations acquired in relation to my participation at the event and the organization of the event for commercial purposes, particularly for the purposes of marketing, advertising, and promotion by administrators, their activities, events organized by them or in their cooperation, as well as for the purposes of marketing, advertising and promotion of administrators at all communication media (particularly the printed and audio-visual), irrespective of their nature and the determination by all common ways, with the subsequent modification and their potential connection with other works or their inclusion into a set of works. I provide this consent free of charge, without any limitation in terms of subject, time, quantification or territory. This consent also applies to third persons, to whom the authorized entity provides the images in accordance with their designation.

In case I do not agree with the publication of the visual records including my person, I will remind the event organizer of this fact no later than during the registration on site. Later notifications cannot be taken into account.

If you require information on the personal data processing, the administrator is obliged to provide this information without undue delay. The content of the information is always the notification on the purpose of the personal data processing, or possibly the categories of personal data, which are subject to processing, including all available information on their source, nature of the automated processing in relation to its use. If you have an impression that the administrator processes personal data in contradiction to the protection of privacy or the law, particularly that it processes imprecise personal data with respect to their purpose of processing, you are authorized to request explanation in writing, and the removal of the potentially defective condition (particularly the blocking, correction, amendment, or liquidation of personal data). If the administrator finds the application to be authorized, the organizer will be obliged to immediately remove the defective condition and inform you in writing (by email) on such measures. If you find that the administrator processes personal data, which are incorrect or are not up-to-date, you are authorized to request the immediate correction of these personal data. If the administrator does not meet your request, you are authorized to contact the Office for Personal Data Protection (hereinafter only “OPDP”). You are authorized to contact OPDP with the request directly, also without any prior application. If, as a result of personal data processing, other than material harm is caused to you, you are authorized to apply claims due to personality protection, based on the appropriate provisions of the Civil Code.
